Section 4: First aid measures

4.1 Description of first aid measures

<u>Skin contact:</u> take off contaminated clothes. Wash the contaminated skin thoroughly with plenty of water and soap. Consult a doctor, if disturbing symptoms appear.



<u>Eye contact</u>: protect the non-irritated eye, remove contact lenses. Wash the contaminated eye with plenty of water for 15 minutes. Avoid powerful water stream – risk of cornea damage. Consult an ophthalmologist if disturbing symptoms appear.

<u>Ingestion:</u> do not induce vomiting. Rinse mouth with water. Never give anything by mouth to an unconscious person. Immediately consult a doctor, show container or label.

<u>Inhalation:</u> remove the victim to fresh air. Keep victim warm and calm. Consult a doctor, if disturbing symptoms persist.

4.2 Most import ant symptoms and effects, both acute and delayed

Skin contact: possible burning sensation, temporary irritation.

Eye contact: possible redness, tearing, temporary irritation.

<u>Ingestion</u>: possible abdominal pain, nausea, vomiting, irritation of digestive tract.

<u>Inhalation:</u> in case of exposure to high vapour concentration possible irritation of respiratory tract, headache and dizziness.

4.3 Indication of any immediate medical attention and special treatment needed

Physician makes a decision regarding further medical treatment after thoroughly examination of the injured. Symptomatic treatment.

Section 5: Firefighting measures

5.1 Extinguishing media

Suitable extinguishing media: extinguishing powder, foam, carbon dioxide.

<u>Unsuitable extinguishing media:</u> water jet – risk of the propagation of the flame.

5.2 Special hazards arising from the substance or mixture

During the fire, the product may produce harmful gases. Do not inhale combustion products, they can be dangerous for human health.

5.3 Advice for firefighters

The product is not flammable. Personal protection typical in case of fire. Do not stay in the fire zone without self-contained breathing apparatus and protective clothing resistant to chemicals. Collect used extinguishing agents. Do not allow them to enter sewers, surface water, groundwater or soil. In case of fire, cool endangered containers with water spray.

Section 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

Limit the access for the outsiders into the breakdown area, until the suitable cleaning operations are completed. Ensure that the effects of breakdown are removed only by trained personnel. In case of large spills, isolate the exposed area. Avoid eyes contact and prolonged skin contact. Do not inhale vapours. Ensure adequate ventilation. Use personal protective equipment. Caution! Risk of slipping on spilled product.

6.2 Environmental precautions

In case of release of large amounts of the product, it is necessary to take appropriate steps to prevent it from spreading into the environment. Notify relevant emergency services.

6.3 Methods and material for containment and cleaning up

Place damaged container in an emergency container. Spills collect with absorbent, e.g. sand, soil, diatomaceous earth, vermiculite, and place it in an appropriate waste containers. Clean and ventilate the contaminated area.

7.1 Precautions for safe handling

Handle in accordance with good occupational hygiene and safety practices. Do not eat, drink or smoke while working with the product. Avoid eye contamination and direct skin contact. Before break and after work wash hands. Do not inhale vapors. Ensure adequate ventilation. Use in accordance with its intended purpose. Keep the unused containers tightly closed. Recommended control procedures

Procedures concerning the control over the dangerous components concentrations in the air and control over the air quality in the workplace – if they are available and justified for the position – in accordance with the European Standards, with the conditions within the exposure place and a proper test methodology adapted to the working conditions.

8.2 Exposure controls

Use the product in accordance with good occupational hygiene and safety practices. When handling do not eat, drink or smoke. Before break and after work wash hands carefully. Avoid eye contamination and prolonged skin contact. Do not inhale vapors. Ensure adequate ventilation in order to maintain the concentration of harmful factors below the limit values.

Hand protection

In case of frequent or long-term contact with the product it is recommended to use gloves resistant to the product. Wear protective clothing.
